- 551.082 Considering discipline of a public school child, or complaint or charge against personnel.

Texas Education Code:

- 39.030(a) Discuss or adopt individual instruments or assessment instrument items.

- (A) In the open meeting covered by the Notice upon the reconvening of the public meeting; or
